

## 2. Hazards identification

<b>Physical state</b>	Solid.
<b>Odor</b>	None.
<b>OSHA/HCS status</b>	This material is considered hazardous by the OSHA Hazard Communication Standard (29 CFR 1910.1200).
<b>Emergency overview</b>	WARNING! Harmful if swallowed. Irritating to eyes, respiratory system and skin. Do not ingest. Avoid contact with eyes, skin and clothing. Contains material that may cause target organ damage, based on animal data. Use only with adequate ventilation. Keep container tightly closed and sealed until ready for use. Wash thoroughly after handling.
<b>Routes of entry</b>	Dermal contact. Inhalation. Ingestion.
<b>Potential acute health effects</b>	
<b>Inhalation</b>	Irritating to respiratory system.
<b>Ingestion</b>	Harmful if swallowed. Can cause target organ damage. Ingestion may cause gastrointestinal irritation and diarrhea.
<b>Skin</b>	Irritating to skin. Skin inflammation is characterized by itching, scaling, reddening or, occasionally, blistering.
<b>Eyes</b>	Irritating to eyes. Adverse symptoms may include the following: redness, itching, swelling, pain.

## 2. Hazards identification (continued)

### Potential chronic health effects

#### Chronic effects

Contains material that can cause target organ damage. Adverse symptoms may include the following:

**Tin:** Prolonged or repeated exposure may cause benign pneumoconiosis (Stannosis).

**Metal:** Other Symptoms include: abdominal cramps and pain, metal fume fever, coughing, chills or shivering, muscle weakness. Prolonged or repeated contact may cause dermatitis. Chronic effects may cause dizziness/vertigo, drowsiness/fatigue, anorexia. Can cause adverse reproductive effects in females.

#### Target organs

Contains material which may cause damage to the following organs: blood, kidneys, lungs, the nervous system, liver, mucous membranes, cardiovascular system, upper respiratory tract, skin, eyes.

#### Carcinogenicity Mutagenicity

Not classified or listed by IARC, NTP, OSHA, EU and ACGIH.

#### Developmental effects

## 4. First aid measures

#### Eye contact

Check for and remove any contact lenses. Get medical attention if irritation occurs. Immediately flush eyes with running water for at least 30 minutes, keeping eyelids open.

#### Skin contact

Flush contaminated skin with plenty of water. Remove contaminated clothing and shoes. Continue to rinse for at least 15 minutes. Get medical attention if symptoms occur. Wash contaminated clothing before reuse. Clean shoes thoroughly before reuse. Seek medical attention if irritation persists. In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

#### Inhalation

Get medical attention immediately. Move exposed person to fresh air. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. Keep person warm and at rest. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

## 4. First aid measures (continued)

<b>Ingestion</b>	Get medical attention immediately. Wash out mouth with water. Remove dentures if any. Move exposed person to fresh air. Keep person warm and at rest. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel.
<b>Protection of first-aiders</b>	No action shall be taken involving any personal risk or without suitable training. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Wear suitable protective clothing, gloves and eye/face protection. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus.

## 5. Fire-fighting measures

<b>Flammability of the product</b>	No specific fire or explosion hazard.
<b>Extinguishing media</b>	
<b>Suitable</b>	Use an extinguishing agent suitable for the surrounding fire.
<b>Not suitable</b>	None known.
<b>Special exposure hazards</b>	Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training.
<b>Hazardous combustion products</b>	Metal oxide/oxides
<b>Special protective equipment for fire-fighters</b>	Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.

## 6. Accidental release measures

<b>Personal precautions</b>	No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment (see section 8).
<b>Environmental precautions</b>	Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
<b>Large spill</b>	Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Vacuum or sweep up material and place in a designated, labeled waste container. Dispose of via a licensed waste disposal contractor. Note: see section 1 for emergency contact information and section 13 for waste disposal.
<b>Small spill</b>	Move containers from spill area. Vacuum or sweep up material and place in a designated, labeled waste container. Dispose of via a licensed waste disposal contractor.

## 7. Handling and storage

<b>Handling</b>	Put on appropriate personal protective equipment (see section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Avoid contact with eyes, skin and clothing. Do not ingest. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Keep in the original container or approved alternative container. Containers should be kept closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

### Storage

Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see section 10) and food and drink. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.

Keep container in a cool, well-ventilated area. Keep container tightly closed and sealed until ready for use. Avoid all possible sources of ignition (spark or flame).

### Recommended monitoring procedures

If this product contains ingredients with exposure limits, personal, workplace atmosphere or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment.

### Engineering measures

Use only with adequate ventilation. If user operations generate dust, fumes, gas, vapor or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. Processes should be designed to minimize airborne and skin exposure to hazardous substances.

### Hygiene measures

Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Appropriate techniques should be used to remove potentially contaminated clothing. Wash contaminated clothing before reusing. ### Personal protection

#### Respiratory

#### Hands

Chemical-resistant, impervious gloves complying with an approved standard should be worn at all times when handling chemical products if a risk assessment indicates this is necessary.
